

**Technical Information: Real Food Blends™**  
**Item 49746: Orange Chicken, Carrots, and Brown Rice**  
**Enteral Feeding Liquid Meal**

<b>Description</b>	Real Food Blends™ Orange Chicken, Carrots, and Brown Rice is a pre-packaged pureed food meal that is fed via feeding tube. Each 8 fluid ounce (267g) portion delivers 14 grams protein, 19 grams fat and 28 grams of carbohydrate in 340 calories.
<b>Ingredients</b>	Orange juice, cooked chicken, carrots, brown rice, grapeseed oil, water, ginger, roasted sunflower seeds
<b>Caloric Distribution</b>	17% calories from protein; 33% calories from carbohydrate; 50% calories from fat
<b>Protein Source</b>	Chicken
<b>Carbohydrate Source</b>	Orange juice, carrots, brown rice
<b>Fat Source</b>	Grapeseed oil, sunflower seeds
<b>Water Content</b>	75%

Flush tube with water after feeding.
<b>Shelf Life</b>	3 years from date of manufacture, unopened, at room temperature
