Description	Real Food Blends™ Salmon Oats & Squash is a pre-packaged pureed food meal that is fed via feeding tube. Each 8 fluid ounce (267g) portion delivers 13 grams protein, 20 grams fat and 26 grams of carbohydrate in 330 calories.
